**Deposit:** For families new to the school, a tuition deposit of the first month's payment is required within 15 days after parents have been sent a letter of approval notifying them that their child has been accepted. Tuition deposits are nonrefundable. The deposit is applied to the total tuition.

**Payment Plan:** Nine monthly payments paid beginning August 1st and paid on the first of each month thereafter:

## Past-Due Accounts/ Returned Checks:

Tuition is due by the 1<sup>st</sup> of each month. If payment is received after the 5th a late fee of \$15.00 will be charged. If tuition is beyond 60 days past due (example: due 8/1, not received as of 10/1) the parent/guardian will receive formal notification that all accounts must be resolved within 15 days, or the Administrator is authorized to dis-enroll at that time. A fee of \$35.00 will be charged for dishonored checks or money orders.
